The Direct Debit Guarantee

- If there are any changes to the amount, date or frequency of your Direct Debit the Royal Institution will notify you 15 working days in advance of your account being debited or otherwise agreed.
- If you request the Royal Institution to collect a payment, confirmation of the amount and date will be given to you at the time of the request.
- If an error is made in the payment of your Direct Debit, by the Royal Institution or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your bank or building society. If you receive a refund you are not entitled to, you must pay it back when the Royal Institution asks you to.
